Analytics Cookies	<p>Collect data which helps us analyze how you interact with and use of our Services and website(s) so that we can measure and improve performance and build better features.</p> <p>We use LastPass and third-party Cookies from Segment, Pendo, Google Analytics, and Google Crashlytics to provide us with anonymous analytics on the use of the Services to improve and enhance our Services or identify issues.</p>
Advertising Cookies	<p>Collect data that may be used to serve or deliver ads that are more relevant to your interests. These may include third-party cookies in which these third-party companies may collect and combine information about your online activities over time, on other devices, and on other websites or online services, if those websites and online services also partner with the same companies.</p>
